A N N O U N C E M E N T

Pursuant to Art. 18a, para. 10 of the Administrative Procedure Code (APC), in connection with Order № 3-OX-34 of 30.04.2025 of the EWRC Chairman, we hereby inform:

I. At a closed session held on 25.09.2025, Energy and Water Regulatory Commission (EWRC) with an Act for establishing public state receivable № УДБ-27 of 25.09.2025 has established a public state receivable in respect of **TPS POWER TRADING SRL, with Unified Registration Code № 33450818 of 04.08.2014 and registration number in the commercial register № J40/9172/2014 at the court in Bucharest, Romania**, with a principal amount of BGN 51 061,93 (EUR 26 107,52) and interest for delay in the amount of BGN 5,559.29 BGN (EUR 2,842.42).
