A N N O U N C E M E N T

Pursuant to Art. 18a, para. 10 of the Administrative Procedure Code (APC), in connection with Order No 3-OX-34 of 30.04.2025 of the EWRC Chairman, we hereby announce:

I. At a closed session held on 18.03.2026 by Act No. УДБ-14 of 18.03.2026 establishing a public state claim, the Energy and Water Regulatory Commission (EWRC) has opened a procedure for establishing a public state receivable in respect of **TPS POWER TRADING SRL, with single registration code No. 33450818 of 04.08.2014, serial number in the commercial register J40/9172/2014 at the court in Bucharest, Romania and service number in the register of the National Revenue Agency of Bulgaria: 3171231247, having seat and address of management: Romania, city of Bucharest, 15 Constantin Aricescu str., room No 2, with a principal amount of EUR 572,76 (BGN 1 120,22) and interest for delay at the amount of EUR 25,03 (BGN 48,95). Statutory interest for delay is due on the unpaid principal of EUR 572,76 (BGN 1 120,22), as of 02.12.2025 until the date of receipt of the amount in the EWRC bank account.**

A letter regarding the Act for establishing a public state receivable No. УДБ-14 of 18.03.2026 in relation to **TPS POWER TRADING SRL** was sent by mail with a delivery notice to addresses known to EWRC. It was returned in its entirety with a note "unknown".
