## ANNOUNCEMENT

On the basis of Art. 18a, para. 10 of the Administrative Procedure Code (APC), in connection with Order No. 3-OX-34 of 30.04.2025 of the Chairman of the Energy and Water Regulatory Commission (EWRC), we hereby inform:

I. At a closed session held on 25.09.2025, EWRC, by Act for Establishing a Public State Receivable No. УДВ-30 of 25.09.2025, established a public state receivable in relation to **ELPETRA ENERGY Ltd**, with registration No 291629 and tax identification number CY 10291629I, according to a good standing certificate issued by the Registry of Companies, Department of the Registrar of Companies, Ministry of Commerce, Industry and Tourism of the Republic of Cyprus, District Court of Nicosia, as well as an official number in the register of the National Revenue Agency of the Republic of Bulgaria: 3076336821, with a total principal amount of 13,348.68 EUR (26,107.77 BGN) and interest for late payment in the amount of 16.02 EUR (31.34 BGN). Statutory interest for delay is due on the unpaid principal until the date of receipt of the amount in the EWRC bank account:

- On 11,537.12 EUR or 22,564.65 BGN (second installment for 2021), as of 01.12.2021;
- On 511.29 EUR or 1,000.00 BGN (first installment for 2022), as of 01.04.2022;
- On 511.29 EUR or 1,000.00 BGN (second installment for 2022), as of 01.12.2022;
- On 788.98 EUR or 1,543.12 BGN (fee until the license validity date: 07.10.2023), as of 15.10.2023.

A letter regarding the Act of Establishment of Public State Receivable No. УДВ-30 issued by EWRC dated 25.09.2025 in relation to **ELPETRA ENERGY Ltd** was sent by mail with a notice of delivery to addresses known to EWRC, and the same was returned in its entirety with a note "unknown".

The public state claim established by this act is subject to voluntary payment within 14 days by transferring the amount due to the bank account of EWRC:
